- Evaluating existing HSE regulations are already sufficient for the working conditions on the site.
- Supervising all works in offices, workshop, drilling locations have fulfilled the requirements of Health and Safety at Work.
- Monitoring all activities at the drilling locations associated with HSE compliance.
- Ensure and monitor that the use of PPE is conducted by all personnel at the drilling location.
- Coaching personal or crew aspect HSE who are their responsibility.
- Working closely with the Camp Boss to ensure that catering menu is in accordance with the contract and the guarantee of the security and cleanliness.
- Checking out all the installations of drilling equipment in accordance with HSE requirements.
- Checking all operation vehicles that have already fulfilled the requirements of HSE.
- Submitting report of HSE daily activities to the HSE Representative.
- Making report of Hazard Observation Card (HOC) or PEKA
- Coordinate the implementation of Work Permit and JSA for non-routine or high-risk jobs.
- Monitor Safe Working Codes & Practices implemented and complied with the applicable rules and regulatory standards
- Conduct inspection and observation for identification of permanent hazards to equipment, workplace location (Rig) and unsafe working practices.
- Establishing HSE Program in under his/her organization synchronize with Corporate HSE Program
- Coordinate HSE meetings such as: Tail Gate Meeting, Safety Meeting and others with all personnel at the drilling site regularly and documenting and following up on the results of the talks.
- Assisting local unit managers in managing and minimizing waste due to Rig operations.
- Coordinate and carry out field inspections on a specified schedule and promptly report any unsafe conditions.

## KEY RESULT AREA (KRA) & KEY PERFORMING INDICATOR (KPI)

- Provide an Emergency Response Program and assure all personnel working in the field are aware and involved in it.
- Investigate the near misses, work accidents resulting in human injury, fire and equipment damage and immediately reported to the Rig Superintendent or supreme leader of the local unit.
- Conduct scheduled inspections of safety equipment in each Rig and report the inspection results to the Main Supervisors of HSE Area and Rig Superintendent.
- Create a HSE field performance report periodically according to the HSE program of each Area.
- Make sure, monitoring CSMS (Contractor Safety Management System) implementation leading indicator and lagging indicator.
